

TALLY ENERGY HONORED AS SILVER STEVIE® AWARD WINNER IN 2018 AMERICAN BUSINESS AWARDS®

HOUSTON, TX (May 24, 2018) – Tally Energy Services was named the winner of a Silver Stevie® Award in the Startup of the Year category in the 16th Annual American Business Awards®.

The American Business Awards are the U.S.A.'s premier business awards program. All organizations operating in the U.S.A. are eligible to submit nominations – public and private, for-profit and non-profit, large and small.

Nicknamed the Stevie's for the Greek word meaning "crowned," the awards will be presented to winners at a gala ceremony at the Marriott Marquis Hotel in New York on Monday, June 11.

More than 3,700 nominations from organizations of all sizes and in virtually every industry were submitted this year for consideration in a wide range of categories, including Startup of the Year, Executive of the Year, Best New Product or Service of the Year, Marketing Campaign of the Year, Live Event of the Year, and App of the Year, among others. Tally Energy was nominated in the Startup of the Year category for Business Services.

After recently launching its operations in Houston, Texas, Tally has made four acquisitions bringing its employee count from 50 to over 150. Tally is principally focused on directional drilling, completion equipment, and artificial lift.

"Their hard work and dedication has helped drive new ideas, acquisitions, and development of our buy and build strategy. We are honored to accept the Silver award from the American Business Awards."
